2. Website access and server logs (hexalinq.com and all subdomains)

- When our servers are accessed, we might log parts of the communication (e.g. HTTP headers) to help us identify potential security threats or breaches, thus keeping your data safe.
- Such logs might contain personally identifiable information, like your IP address and User-Agent string.
- Server logs older than 30 days are automatically deleted.

3. Contact form

- You may contact Hexalinq using the contact forms on our websites.
- Personal information is collected on the basis of consent, and it includes your full name, company name, email address, phone number, and any personal information you enter in the subject and message fields.
- We keep such information as long as needed to fulfill your request.

4. Hexalinq account

- The only personal information, that is always associated with a Hexalinq account, is your primary email address.
- If you ever choose to subscribe to any of our paid services or you purchase our products, we collect additional personal information for payment processing and invoice issuance, which includes your full name, company name, billing address, and tax identification number.
- Our payment processor (PayPal) might collect additional information. Read their privacy policy here: <https://www.paypal.com/us/webapps/mpp/ua/privacy-full>
- Hexalinq keeps these information until you close your account, to be able to provide you the services.

5. Binary Workbench

- Binary Workbench itself does not collect any personally identifiable information, but the uploaded files or entered data might contain some.
- These files are kept until you delete the associated project or close your Hexalinq account.

6. Newsletters

- Newsletters are sent using Google Gmail. Read their privacy policy here: <https://policies.google.com/privacy>
- Collected data includes your first name and email address, and are collected on the basis of consent.
- You can opt out at any time using the unsubscribe link at the bottom of the emails, or by contacting us at privacy@hexalinq.com

7. Your rights

- Hexalinq is fully GDPR compliant, which means you have full control over your personal data.
- You can request to receive an exported file of all personal data we have about you, or to rectify or erase all such data.
- You also have the right to withdraw your consent, to be notified of data breaches, and to file a complaint to a supervisory authority.
- We respond to all requests within 30 days, as required by GDPR.
